# House of Deputies & House of Bishops

---

The House of Deputies has between **800-1000** clergy and lay members representing all nine provinces of The Episcopal Church. The House of Bishops includes **every bishop**, presently consisting of about 300 active members.

# Deputies and Alternate Deputies

Each diocese elects **four clergy deputies and four lay deputies** and between two and four alternates to serve for three years (the triennium). They are referred to in rank order of votes received.



# Resolution D036 Expand Statute of Limitations for Title IV (Amend Canons)

---

*(b) The time limits of Subsection (a) above shall not apply with respect to persons whose acts include physical violence, sexual abuse or sexual exploitation, if the acts occurred when the alleged Injured Person was under the age of twenty-one years; in any such case, proceedings under this Title may be initiated at any time.*





# Resolution A068 Plan for the Revision of the Book of Common Prayer

---

Resolución A068: Plan para la Revisión del Libro de Oración Común



For a fuller understanding of the implications of the adoption of this resolution, please speak with Deputy Matt Mead, who served on the Legislative Committee.

Of note in resolve #6 is the call for the creation of diocesan liturgical commission to explore and experiment with language and liturgy.

What follows are the important ‘resolves’ from the Prayer Book Revision Resolution. First in English, then in Spanish

*Lo que sigue son los importantes 'resuelve' de la Resolución de Revisión del Libro de Oración. Primero en inglés, luego en español*

- 3 *Resolved*, That the 79th General Convention create a Task Force on Liturgical and Prayer Book Revision (TFLPBR), the membership of which will be jointly appointed by the Presiding Bishop and the President of the House of Deputies, and will report to the appropriate legislative committee(s) of the 80th General Convention, ensuring that diverse voices of our church are active participants in this liturgical revision by constituting a group with leaders who represent the expertise, gender, age, theology, regional, and ethnic diversity of the church, to include, 10 laity, 10 priests or deacons, and 10 Bishops; and be it further
- 4 *Resolved*, That this Convention memorialize the 1979 Book of Common Prayer as a Prayer Book of the church preserving the psalter, liturgies, The Lambeth Quadrilateral, Historic Documents, and Trinitarian Formularies ensuring its continued use; and be it further
- 5 *Resolved*, That this church continue to engage the deep Baptismal and Eucharistic theology and practice of the 1979 Prayer Book; and be it further
- 6 *Resolved*, That bishops engage worshiping communities in experimentation and the creation of alternative texts to offer to the wider church, and that each diocese be urged to create a liturgical commission to collect, reflect, teach and share these resources with the TFLPBR; and be it further

- 4 *Se resuelve*, Que esta Convención conmemore el Libro de Oración Común de 1979 como un Libro de Oración de la iglesia preservando el salterio, las liturgias, el Cuadrilátero de Lambeth, los Documentos Históricos y los Formularios Trinitarios, asegurando su uso continuo; y asimismo
- 5 *Se resuelve*, Que esta iglesia continúe recurriendo a la profunda teología bautismal y eucarística y prácticas del Libro de Oración Común de 1979; y asimismo
- 6 *Se resuelve*, Que los obispos involucren a las comunidades de adoración en la experimentación y la creación de textos alternativos para ofrecer a la iglesia en general, y que se pida a cada diócesis que cree una comisión litúrgica para recopilar, reflejar, enseñar y compartir estos recursos con TFLPBR; y asimismo

# Marriage rites: please note

---

*Resolved*, That in dioceses where the bishop ... holds a theological position that does not embrace marriage for same-sex couples, and there is a desire to use such rites by same-sex couples in a congregation or worshipping community, the bishop ... shall invite, as necessary, another <sup>God</sup> bishop of this Church to provide pastoral support ...

*(and)* “It shall be within the discretion of any Member of the Clergy of this Church to decline to solemnize or bless any marriage”;

# Marriage rites: please note

---

(resolved that) A Task Force on Communion across Difference, seek a lasting path forward for mutual affirming (1) the clear decision of General Convention that Christian marriage is a covenant between two people, of the same sex or of the opposite sex, (2) General Convention's firm commitment to make provision for all couples asking to be married in this Church to have access to authorized liturgies; and also affirming

(3) the indispensable place that the minority who hold to this Church's historic teaching on marriage have in our common life, whose witness the Church needs.

# Resolution B012 Marriage Rites for the Whole Church

---

## Resolución B012 Ritos de matrimonio para toda la iglesia

Authorizes the continued trial use of the four blessings in use for same sex marriages, and provide translations into Spanish, French and Haitian Creole available electronically by Advent 2018.

### The Marriage

Each member of the couple, in turn, takes the right hand of the other and says

In the Name of God, I, \_\_\_\_\_, take you,  
\_\_\_\_\_, to be my *wife/husband/spouse*,

# Resolution C014 Suicide Prevention Advocacy and Clergy Training

---

Resolución C014 Promoción de la prevención del suicidio y educación del clero

Sponsored from our diocese by The Rev. Bob Flanagan, the LC determined that we had not requested enough funding and so they increased it...**by a factor of ten.**

*Resolved*, That the institutions and **diocesan programs that educate Priest and Deacon candidates be requested to offer four (4) hours of suicide prevention education**, using evidence-based trainings, for its students, and that dioceses offer similar suicide prevention training for their clergy; and be it further

*Resolved*, That the General Convention request the Joint Standing Committee on Program, Budget and Finance to consider a budget allocation of \$7,500 for the implementation of this resolution; and be it further

# Resolution C014 Suicide Prevention Advocacy and Clergy Training
