## The Heartbeat of Wounded Knee: Native America from 1890 to the Present



## WAKING UP WHITE, AND FINDING MYSELF IN THE STORY OF RACE.

*Irving, Debby. 2014.*

A memoir/recollection of her experience as a WASP (White Anglo Saxon Protestant) American. The book addresses white privilege and the complexity of race in the U.S.

## THE COLOR OF CHRIST: THE SON OF GOD AND THE SAGA OF RACE IN AMERICA.

*Blum, Edward J. and Harvey, Paul. 2012.*

Explains how the image of Jesus was used to reinforce racism and how that image became blond and blue-eyed.

## WHITE TRASH: THE 400 YEAR HISTORY OF CLASS IN AMERICA.

*Isenberg, Nancy. 2016.*

A Cultural and Political history of an American underclass.

## BLACK MAN IN A WHITE COAT: A DOCTOR'S REFLECTION ON RACE.

*A doctor's reflection on race and medicine.*

## INVISIBLE MAN, GOT THE WHOLE WORLD WATCHING.

*DiAngelo, Robin. 2018.*

The New York Times best-selling book exploring the counterproductive reactions white people have when their assumptions about race are challenged, and how these reactions maintain racial inequality.

## Stand Your Ground: Black Bodies and the Justice of God.

*Douglas, Kelly Brown. 2015.*

The 2012 killing of Trayvon Martin, an African-American teenager in Florida, and the subsequent acquittal of his killer, brought public attention to controversial "Stand Your Ground" laws. This book is an attempt to take seriously social and theological questions raised by this and similar stories, and to answer black church people's questions of justice and faith in response to the call of God.
